1. Responding to terminal equipment such as nonconformity with technical standards

- Along with the diversification of terminal equipment such as Mobile phones and Wireless LANs and the complexity of these functions, Examples of non-conformity etc. related to the standard certification system of telecommunications equipment (non-conformity to technical standards) have been occurring.
- If MIC confirms the non-conformity to technical standards, the facts grasped by MIC will be announced. By notifying the users and related stakeholders in this manner, MIC is working to prevent expand the damage and similar cases from recurring.
- In addition, MIC is conducting sample surveys targeting terminal equipment actually sold on the market (Market Surveillance). MIC also provide information on non-conformity to technical standards confirmed by Market Surveillance to users, stakeholders, etc. from time to time.

4. Items of caution to stakeholders [1/2]

- Conformity mark in certification system of terminal equipment in Japan is proof to prove that the equipment conforms to the technical standards specified by the Telecommunications Business Act etc. However, in the case of non-comformity to technical standards recently, the following terminal equipment and vendors are confirmed.
 - A) Terminal equipment to which conformity mark is affixed although it does not conform to technical standards
 - B) Manufacturer who manufactures and sells terminal equipment different from the design that certified
 - C) Terminal equipment whose display content is inappropriate (Including terminal equipment that is not displayed even though this is certified one)
 - D) Companies and terminal equipment sold at domestic home electronics mass merchandising stores or EC stores without obtaining conformity certification
- Terminal equipment that dose not display conformity marks may not be certified by registered approval body and may not comply with technical standards. For this reason, a great troublesome will be caused to users who do not know.

To Manufacturer, Importer or Distributor of terminal equipment

 Please make sure that manufacturers, importers or distributors of the terminal equipment always inquire of the registered approval body whether it is a terminal equipment requiring conformity to technical standards before shipping and selling to the users or mass merchandisers.

To Foreign CABs based on MRA, and To CABs in Japan

- Foreign CABs and JPN's CABs should conduct fair and appropriate certification work to prevent impairment of the trust of conformity marks, as following,
 - ✓ Please follow strictly Telecommunication Business Act and regulations of your company.
 - ✓ When checking applications for conformity certification, Please confirm whether
 the test data is copy diversion or not.
 - ✓ And if you find such inappropriate test data, please guide the applicant properly.
